

National Coalition to End Child Abuse Deaths

More than 2,500 American children die each year from abuse and neglect.

In the U.S., a child is abused or neglected every 36 seconds. According to the U.S. Department of Health and Human Services, only 40% of abused children with substantiated cases receive services.

Researchers estimate that nearly 7 children die in America every day from abuse and neglect. That is an alarming rate of 2,500 child deaths per year.

Federal data shows that 13,856 children are known to have died from abuse and neglect between 2001 and 2009. Some experts believe the actual number may be more than 20,000 child deaths.

Progress

- Law and Order: SVU's Tamara Tunie ("Dr. Melinda Warner"), Coalition spokesperson, and experts testified about child abuse and neglect deaths at a congressional hearing held by the House Committee on Ways and Means on July 12, 2011
- Held a press conference with experts which resulted in 25 national media stories on child abuse and neglect deaths
- Released the second edition of We Can Do Better: Child Abuse and Neglect Deaths in America, highlighting the official number of child abuse and neglect deaths for 2008 – a number significantly higher than many more commonly publicized causes of death

The Year Ahead

- Guide the drafting of Senate and House legislation creating a National Commission on Child Abuse Deaths
- Enlist the national media to raise public awareness of child abuse and neglect deaths
- Urge the Administration and Congress to take action to prevent child abuse and neglect deaths
